Whereas; this older community has limited traffic and no desire for additional sidewalks And

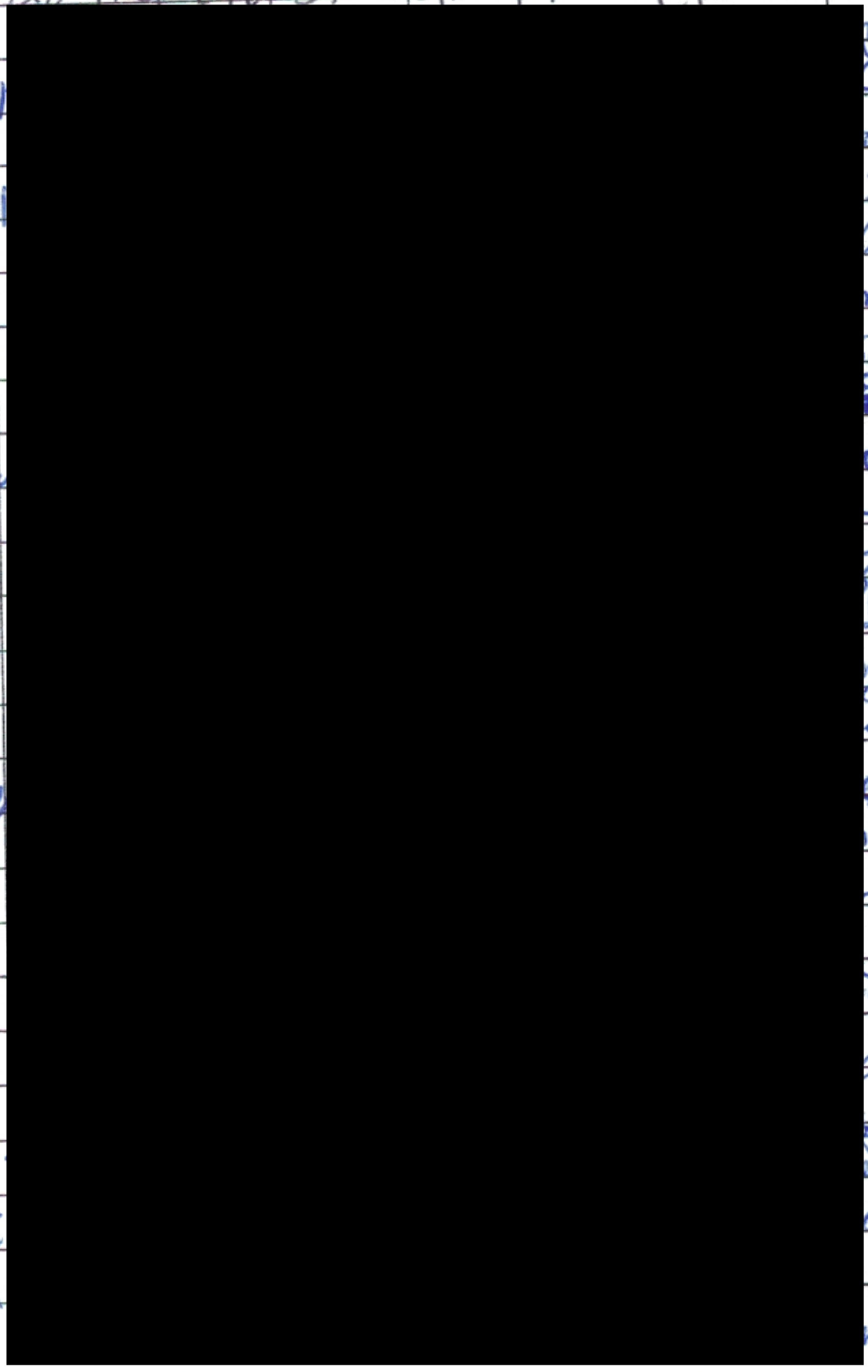
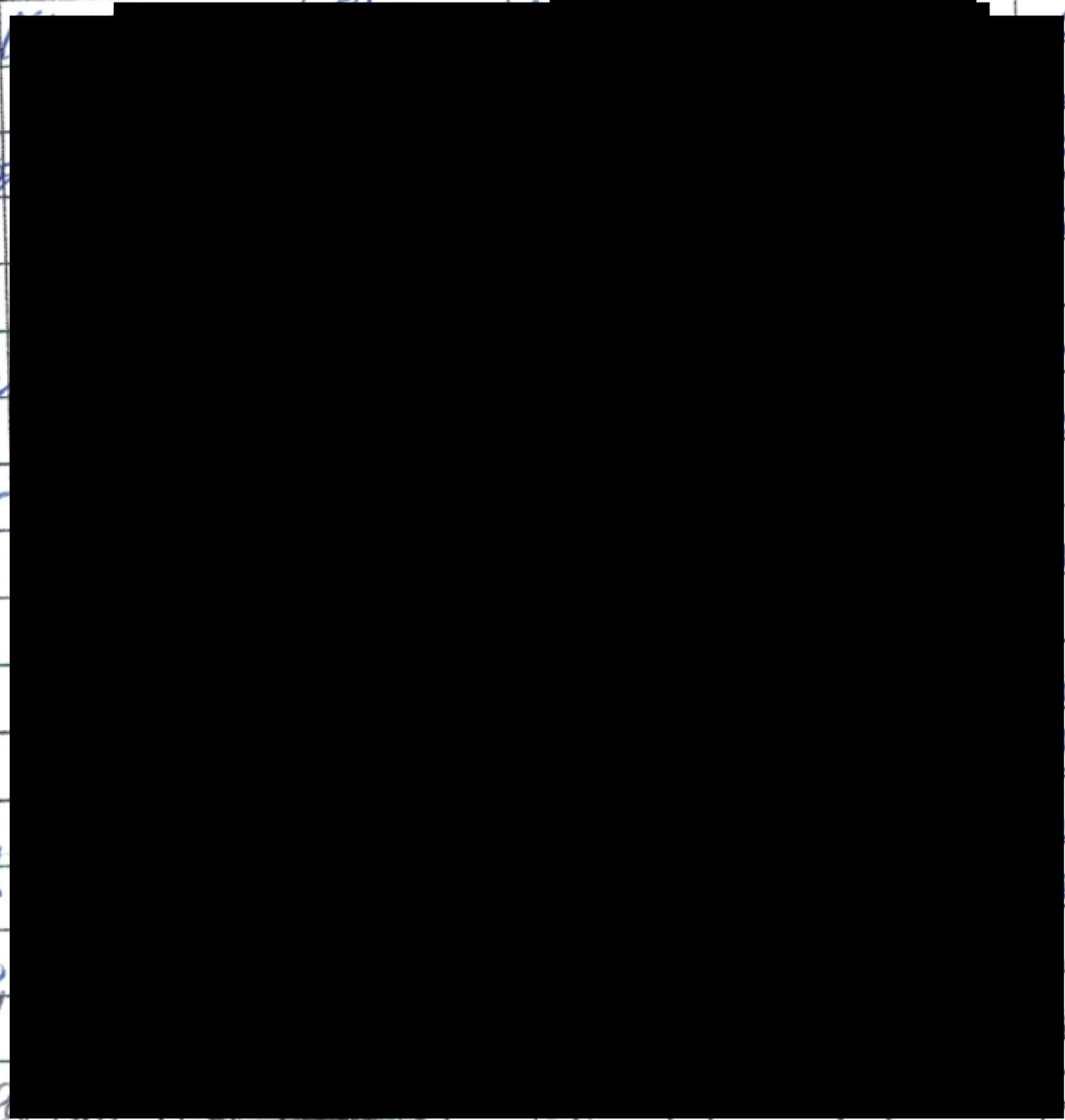
Whereas there is no Street providing through traffic to other communities And
