SUBJECT: First Half 2022 Building Activity Summary

RECOMMENDATION

THAT the First Half 2022 Building Activity Summary be received for information

BACKGROUND:

The purpose of this report is to advise Council of the status of building permit activity for Southwest Middlesex for the first half of 2022.

Although new residential building permit activity for the first half of 2022 has been generally consistent with 2021, minor residential projects such as renovations and accessory buildings has significantly increased as has agricultural permits. New construction values for 2022 totaled over \$12 million while 2021 permits were slightly under \$5 million. New residential starts for 2022 and 2021 totaled 7.

Staff is currently drafting a new Building By-law to be taken to council as soon as possible. Fees paid to Middlesex Centre for inspection services over the first half total approximately \$44,000.
