Building Permit 4th Quarter and Year End 2022

RECOMMENDATION:

That the Building Permit 4th Quarter and Year End 2022 summary be received for information

BACKGROUND:

This report is to advise Council of the status of building permit activity for Southwest Middlesex for the fourth quarter of 2022 and to provide year end totals.

ANALYSIS:

Building permit activity for 2022 has been generally consistent with previous years. New residential starts for 2022 total 13 (12 dwellings plus 1 mobile home). Fees paid to Middlesex Centre for inspection services for 2022 total approximately \$88,470.

Starting in 2021, a building inspection services agreement was entered into with Middlesex Centre. This service agreement services Adelaide Metcalfe, Lucan Biddulph, Middlesex Centre, North Middlesex and Southwest Middlesex. A summary of permits issued in this group of municipalities is provided below in Table 5: Information pertaining to the fourth quarter and year end building permit activity in Southwest Middlesex is outlined below in Tables 1 to 4 below;
