

Budget Survey 2024: Written Comments

In the Creating our Budget survey (July - August 2023), residents were asked **"What do you think is the single biggest challenge facing Middlesex Centre that the budget should address?"**

One-hundred and ninety (190) residents responded to the question. The responses are presented below as they were received – no edits were made – except in a few instances where the comments were derogatory nature or where the comments could lead to a specific individual being identified.

Staff sorted and combined responses on similar issues / topics. If a resident commented on more than one issue in a response, their response was split to allow for response to each topic.

These comments were shared with Municipal Council as they began deliberations on the 2024 Middlesex Centre Budget.

By-law & Building Services

- By-law enforcement for burning in Ilderton should be looked at more closely (ie enforced).
- Our neighborhood has become a trailer park. RVs are parked in driveways everywhere all year round. It's very unsightly and makes pulling out of your own driveway with a car unsafe because the reduce visibility to oncoming traffic
- Three of us own 48 acres of bush which has been classified as residential/farm. There is no farming done nor is there any residence on the property. However one of the owners who lives near the property has found evidence of hunting, hunting gear such as cameras and blinds put there illegally. This is of concern to us should there be an accident. What has Middlesex Centre done for us to prevent illegal hunting?

Fire Services

- Fire services to Komoka/Kilworth
- The fact that the most densely populated area (Komoka/kilworth) does not have a fire department within reasonable response time given all the new construction type homes which have a much quicker burn rate!!!

Public Works & Engineering -Transportation

Active Transportation

- 13 mile road is a popular cycling route for us and many others....why do we have no bike lanes??
- Accessible leisure spaces to walk and enjoy our community would be nice if it were expanded. The service road that runs parallel to Willow Ridge and runs along the Stanton farm is not maintained and an eye sore. Connecting this to existing paths would encourage neighbours to be out more and enjoy our community. The old rail trail is a lovely example of a nice space to walk and it would be nice to connect paths in the different neighborhoods.

- Cycling trails
- Followed by sidewalks/bike path between Komoka and Kilworth (it's the county's responsibility but it's the lives of the residents and kids of Komoka and Kilworth that are at risk.
- Safe bike lanes on roads
- There are very few trails, we moved outside of London for more trails and green space and are disappointed to find that London has more.
- Walking and or bike trails seem to be almost non-existent. Build some!!!! County Roads that go through our muncipality. Improving those.
- Walking trails/ sidewalks
- We are a country community. Without enough Greenspace for walking/biking. YOU visit city communities and they have residential areas built around lakes and miles of trails to walk. Run/bike. We only have small short paths and many lead through the community. Lambeth and Sunningdale are great examples of Residential areas creating great walking/bike trails.
- With the population exploding in Kilworth and Komoka, we need to plan around ways to get around that don't require a car. Walking paths, bike paths.

Traffic and Transportation Planning

- A sufficient crosswalk for kids walking to Parkview when crossing Komoka Rd. There are no safe routes.
- Although i believe Msex centre is not responsible for Glendon Dr, maybe you have influence. Sidewalks along Glendon Dr are needed.Traffic along Glendon Dr has increased immensely. I see older children and young adults walking on the shoulder of the road hence the need for sidewalks. Perhaps a bike lane too.

- As the Ilderton community grows, I have concerns about additional traffic brought to our neighborhood. The speed of traffic on Hyde Park Rd from the fire station to the lights at Ilderton Rd is dangerous. Few obey the speed limit and I've personally almost been struck by a vehicle and witnessed it with others while trying to cross over Hyde Park. The current crosswalk is not suitable for a village this size and makes no sense given there is a proper crosswalk north of Ilderton Rd on Hyde Park. Please consider installing a flashing light crosswalk south of Ilderton Rd.
- Before any new development we need to expand the road going into London at west 5 and fix the intersection at Jefferies and Oxford street extension.
- Better traffic flow, better traffic signage in neighbourhoods. 4-way stop signs would be more beneficial to keeping people safe and slowing down drivers. Especially at westbrook dr. and westbrook dr.
- ensuring flow of traffic
- Expanding Glendon Dr faster. Many houses are going up and the traffic is heavy
- Focus should be on road safety/addressing speeding issues within our communities
- Given the significant increase in the number of new homes, and traffic on our streets, I think that traffic management, road expansion, building of roundabouts and signage is of prime importance.

- Not sure if this is the biggest challenge, but a proper pedestrian crosswalk (with lights) is required urgently at Hyde Park Rd and Heriftahe Drive. It's a currently a tragedy waiting to happen
- Not sure when talking to my neighbors we are very concerned about cars always speeding on our road. No speed limits are posted and on a country road we do not feel that we should have anything over 60 KM, often the roads are not too wide and it is very dangereous when speeding. Its an accident waiting to happen. Perhaps speed bumps would help...
- Pedestrian lights should be placed along gideon drive from kilworth heights west as a lot of people are crossing that street going into foodland and the community center. In order for it to be accessible and safe for these kids who risks their lives when they cross here.
- Put in a proper crosswalk with lights at the medical centre library on Hyde Park Road like the one north of there on Ilderton Road where no one is crossing at!
- replace speed bumps with.""! STOP SIGNS' ! They should accomplish your goals and create a possible cash flow ? You don't seem to know how many people are upset with these installations.
- Road and bicycle safety
- Road safety/ traffic management at five corners and at the bridge
- Road to access London wider but not once in London. Traffic is already an issue along Glendon and will be much worse with new planned builds.
- safer roads (ex: longwoods road, Victoria/Springer crossing. Put in a light or crosswalk light and reduce speed thru Delaware hill to 40.
- Sidewalks need to be added to main roads for safety
- Speed of traffic through the village
- Speeding and road safety for both drivers and pedestrians.

- The placement of speed video posts on Longwood Road in Delaware are in a dumb location. Video signs do not thank the driver for slowing down. For example I go 61 kph going up the hill and the video thing telling me too fast.
- The services you do provide don't have the best interest of the community and only respond to complaints. Too many speed bumps in areas where they are not needed and not enough around children's areas. Clear that the city is responding to small groups of complainers rather than looking at what is in the best interest of the community.
- To be honest there is more than one...crosswalk
- Too many speedbumps on too many streets. I understand the ones in front of parks, but they don't need to be on all streets. More permanent traffic calming measures would be prepared. An example is on Jefferies. 6 speed bumps are unnecessary especially considering there are no houses that look onto that street. That is the road you want more traffic to take. You don't want them in the subdivisions trying to avoid the speed bumps.

- With the influx of new development the single biggest challenge is by far traffic. We need to look ahead to build the infrastructure needed now to support and handle the huge increase of vehicles on our roadways.

Road and Sidewalk Maintenance

- better rural road maintenence
- Cleaning of the internal roads during winter/snow days are delayed by a week on an average time frame specially in the new build area. Roads are slick and no maintenance of side walks. People also often block the sidewalk with vehicles making it inaccessible to walk past their home resulting in slip, trips and falls when you have to go from the side.

- When looking at upcoming budget I would like • to see MC Improve road conditions and safety. This service has drastically declined since we originally moved to Middlesex Centre and with the increased amount of vehicles and pedestrian traffic MC needs to ensure the safety of those using our roadways (both driving and walking). The current poor physical condition (roadway surfaces and shoulder areas) and their very poor winter maintenance is not at par with other municipalities. Many intersections have been allowed overgrowth of vegetatian along shoulders and abutting land which impedes both vehicular and pedestrian safety (ie., cannot see oncoming traffic and pedestrians have no proper walking areas). Roadway signage should also be improved to ensure safety both during daylight and night time hours. Winter maintenance definitely needs to be improved both in frequency and efficiency, MC should be proactive and not reactive in their roadworks activity.

Public Works & Engineering – Environmental Services

Water Rates

- Also, the cost of water must be addressed it is incredibly high.

- The minimum charges are ridiculous. It is nearly impossible for a single income household to live in Ilderton. Stop punishing single people. Reduce the minimum and start charging people that use above that minimum. I use LESS than half the minimum yet am punished for preservation. Large families (with pools, hot tubs and lawn watering systems), are paying a fraction of what they should be.

I am not suggesting that facilities be built at this end of Middlesex Centre but our tax rates might reflect how far we are from facilities I would bet we have contributed to. I would hope that equity provails.

Examples include the soccer field on Stephen Moore drive that has been excavated for years and has had paths to nowhere paved and sits unfinished. Or the sign posts for speed bumps that were installed but never had signs puta on them. There are examples of waste everywhere.
- We pay so much money, which keeps increasing, and we don't have nearly as many amenities as surrounding towns (like Lucan).

Other

This section includes issues that are out of the jurisdiction of Middlesex Centre, among others.

- As an educator, we need to determine our longrange goals for providing adequate space and support in our local public school. Education is vital to the overall success of any municipality.
- Diversity and inclusion as a lens on all development.

- Daycare centres and child care for the many young families that are moving into Komoka. Though I'm not sure this is necessarily part of the budget, it's a huge hurdle when moving to Komoka. We had an incredibly challenging time finding care for our son when moving here. I feel that with the continued development of Komoka, there will need to be assistance with adding centres to help alleviate this issue.
- Equable services in all areas of the township. Just because I live on a short street shouldn't mean I won't see the snowplow until the end of the day or the next day after a storm. Just because I live in a small village I should still have the option of a recreational activity close to my home.
- EV (electric) motorized bikes are a serious risk to pedestrians since they are silent and often go much too fast. Operators should be required to have a license They should be strictly banned from sidewalks and walkways such as the Thames Valley Parkway. Collisions with a pedestrians could easily be a life-alternating horrendous event.
- Hydro outages
- I think the Municipality could do more in helping to enlarge facilities for the Middlesex Centre Archives and/ or be more a part of encouraging the County to develop a plan for a County Archives. All infrastructure is important but sometimes culture etc. has to be considered also.
- Ilderton has remained stagnant and I have not seen improvents in the last 10 years I have been here with the exception of the skate park. Other towns are booming (Lucan, Komoka, Kilworth,etc.)
- Improved hydro connections. Power outages are too frequent
- Local schools capacity also need to be addressed.
- More attention to the smaller communities in middlesex centre. ie. Birr. It seems to be all about Komoka and Ilderton.
- New residents who think MxC is a "city" and expectations are for city rather than rural. Perhaps in communications the term "rural" should be prioritized.

- Not the new arena in Mount Brydges. Grocery store in Mount Brydges
- Open new school in Kilworth
- Property management. Middlesex Centre is basically a rural community and it would be a shame to allow the encroachment of London to displace valuable farm land that helps to feed the population.
- School district
- School expansion
- The City of London and its encroachment. Although the City's boundaries are defined the influence of traffic etc is overwhelming to those of us who live on the first two or three concessions above the City border. Commuters look for faster less encumbered routes. There has been a very noticeable change in traffic volume on 8 Mile Road since the extension of HWY 100 (Vetran's Memorial) to Clarke Side Rd within the City. I have been told there is an increased volume on Medway Rd and the traffic lights in Ballymote have added to the number of commuters using 8 Mile and 9 Mile to cross the top of the City. I expect this type of trend is appears all around the Middlesex Centre/City of London boundary. Added focus needs to be on traffic control. I worry too that Middlesex Centre will not stand up to the pressure exerted by developers and will allow a further annexation of land north of the current boundary between Sunningdale and Medway Roads. Money in the budget needs to be set aside for traffic analysis/control and keeping the City at bay!
- The single biggest challenge is incompetence. I am paying a residential tax rate to live on Denfield Road, and yet the county still has not harmoized the speed limit in the hamlet of Denfield. When queiried about this, there is no explanation provided...but now I understand why there is a massive hole in the budget and a 7.5% tax increase is needed.
- We pay so much money, which keeps increasing, and we don't have nearly as many amenities as surrounding towns (like Lucan).
 ...supermarket, a library that's actually open would be great
