Recommendation:

That staff report BD-03-2023 be received.

Purpose:

To provide council with an update of building department activity for the first half of 2023.

Information:

New construction activity in Lucan Biddulph for the first half of 2023 has been significantly reduced when compared to the first half of 2022. New dwelling units created in the first half have reduced to 19 compared to 34 plus an apartment building in 2022. Construction values are also reduced to \$8,537,700 from \$29,735,500 in 2022.

Although the issuance of new permits has significantly dropped, construction in Lucan in the second quarter has been very healthy. Staff anticipates this improvement to continue into the second half of 2023.
