Subject: Pre-budget approval for 2024 Capital projects

#### **Recommendation:**

THAT Report CPS-55-2023, the pre-budget approval for 2024 capital projects be received:

AND THAT the 2024 capital projects included in report CPS-55-2023 receive pre-budget approval.

# **Purpose:**

To obtain pre-budget approval from Council on specific 2024 capital projects. This preapproval will allow staff to complete the necessary procurement processes in 2023 to ensure 2024 project deadlines are met.

## Background:

The draft capital budget prepared by staff was presented to Council and the public on November 1, 2023. At that time, staff noted that a council report would be forthcoming to pre-approve the 2024 capital budget to allow staff to being their procurement processes.

#### **Analysis:**

Following the November 1, 2023, council meeting, staff have met and discussed specific projects where the procurement process would be needed to happen in 2023 for their projects. This will allow council a longer time to review the entire 2024 capital project list before providing approval while still allowing staff to get started on specific procurement activities.

## The Projects

### **Facility Services**

Project number 24-6728 for the Wellness Centre Cooling tower for \$172,500 Due to nature of equipment this cooling tower is very integral to the operation of the refrigeration ice plant and for the equipment to be changed out the refrigeration plant has to be shut down for 8-10 hours so the need is there to replace this equipment mid to late February when the weather will allow the refrigeration plant to be turned off for an extended period of time without risking melting of the ice surface. Regular ice programming will have to be cancelled for the day but depending on how quick the replacement goes and how cold it is outside; the evening programs will still be able to be run.

Through LAS Canoe Procurement, Community Services has received priority pricing from Cimco Refrigeration but the lead time is 8-12 weeks thus the earlier they can have it ordered, the greater likelihood of meeting a mid to late February install will be achieved.
