Subject: First Quarter 2024 Building and By-law Enforcement Activity Summary

Recommendation:

THAT Report BLD-04-2024, re: First Quarter 2024 Building and By-law Enforcement Activity Summary be received for information.

Purpose:

To advise Council of the status of building permit activity for Middlesex Centre for the first quarter of 2024.

Background:

Building permit activity for the first quarter of 2024 has continued to reflect the significant slowdown started in mid 2022. In the first quarter of 2024, new residential units and construction value reduced to 8 and \$13 million respectively from 14 dwellings and \$11 million construction value in the first quarter of 2023.

Similar reports will be presented to the councils of Adelaide Metcalfe, Southwest Middlesex, Lucan Biddulph and North Middlesex. Construction in these municipalities has also slowed but not to the same level as Middlesex Centre. These reports will be provided to Middlesex Centre Council following those presentations. Further Middlesex Centre information is outlined below in Tables 1 and 2.

Analysis:

In regard to bylaw enforcement activity, 61 site visits have taken place and 53 new cases have been evaluated for various reasons in Middlesex Centre in the first quarter. Of these, two remain open at the end of this quarter.
