

## **Municipality of Middlesex Centre**

## **BYLAW NUMBER 2024-053**

Being a by-law to amend the Middlesex Centre Comprehensive Zoning By-law number 2005-005 with respect to Concession 2 PT Lot 6 RP 33R21400 Part 1 (geographic Township of Lobo), Municipality of Middlesex Centre, roll number: 393900005015903

**WHEREAS** the Council of the Municipality of Middlesex Centre deems it advisable to amend the Middlesex Centre Comprehensive Zoning By-law 2005-005;

**AND WHEREAS** this By-law is in conformity with the Middlesex Centre Official Plan;

**NOW THEREFORE BE RESOLVED THAT** the Council of the Municipality of Middlesex Centre enacts as follows:

- 1. That Zoning Map Schedule 'A', Key Map U-9 to the Middlesex Centre Comprehensive Zoning By-law 2005-005, is hereby amended by changing from the 'Existing Use exception 3 (EU-3)' zone to the 'Light Industrial exception 4 (M1-4)' Zone, that land drawn in heavy solid lines and identified on Schedule 'A', attached hereto and described as being Concession 2 PT Lot 6 RP 33R21400 Part 1 (geographic Township of Lobo), Municipality of Middlesex Centre.
- 2. That Section 18.3 "Exceptions" be amended by adding the following new subsection:
  - "18.3.4 (a) <u>DEFINED AREA</u>

M1-4 as shown on Schedule "A", Key Map U-9

(b) <u>PERMITTED USES</u>

accessory use laboratory office as an accessory use open storage as an accessory use retail as an accessory use self-storage establishment warehouse

(c) MINIMUM FRONT YARD DEPTH 7 m (22.9 ft)

## (d) MINIMUM SIDE YARD SETBACK

- (i) Notwithstanding Section 18.1.9 of this By-law, the Minimum Side Yard Setback shall be 30.0 m (98.4 ft) for a laboratory.
- (ii) Notwithstanding Section 18.1.9 of this By-law, the Minimum Side Yard Setback shall be 15.0 m (49. 2 ft) for all uses permitted within 18.3.4 b) except laboratory."
- 3. This by-law comes into force and takes effect upon the day of passing in accordance with the provisions of Section 34 of the <u>Planning Act</u>, R.S.O 1990, c. P.13.

**READ A FIRST, SECOND AND THIRD TIME, AND FINALLY PASSED** this 19<sup>th</sup> day of June, 2024.
