

## Municipality of Middlesex Centre BY-LAW 2024-066

## Being a By-law of the Corporation of the Municipality of Middlesex Centre to amend the Parking and Traffic By-law 2018-092

**WHEREAS** pursuant to the *Municipal Act, 2001*, S.O. 2001, c.25 the Council of a local municipality may pass by-laws to provide any service or thing that the municipality considers necessary or desirable to the public;

**AND WHEREAS** subsection 5(3) of the Municipal Act provides that a municipal power shall be exercised by by-law;

**AND WHEREAS** the Council of the Corporation of the Municipality of Middlesex Centre deems it expedient to amend By-Law 2018-092, being a by-law to revise and consolidate certain by-laws regulating Traffic and the Parking of Motor Vehicles;

**NOW THEREFORE BE IT RESOLVED THAT** the Council of the Corporation of the Municipality of Middlesex Centre enacts as follows:

- 1. THAT the title section of PART 2 UNMETERED OFF-STREET MUNICIPAL PARKING be amended to remove the word 'UNMETERED' and shall be titled OFF-STREET MUNICIPAL PARKING:
- 2. AND THAT Section 28 Unmetered Municipal Parking Lots be amended to remove the word 'UNMETERED' and shall be titled Municipal Parking Lots;
- 3. AND THAT Section 28 be amended to add a new 28(1) subsection titled Unmetered Municipal Parking Lots (Schedule 10);
- 4. AND THAT Section 28(1) be amended as follows:

The following premises owned by the Municipality and described in Table 1 below are designated as parking lots to be used for the purposes unmetered parking of motor vehicles until the premises are otherwise required by the Municipality.

5. AND THAT Section 28 be amended with the addition of a Section 28(2) as follows:

## (2) Metered Municipal Parking Lots

The following premises owned by the Municipality and described in Table 2 below are designated as parking lots to be used for the purposes of metered parking of motor vehicles. No person shall park a vehicle in any parking space or part thereof, for a period longer than that for which payment has been made.

- 6. AND THAT the reference to 'Section 28' found under Section 30 Lawful Use of Space (Schedule 13) be deleted and replaced with 'Section 28(1)'
- 7. AND THAT Table 2 found under Section 30 Lawful Use of Space (Schedule 13) be amended to read Table 3
- 8. AND THAT the schedule for Set Fines (Part 2) be amended with the addition of the following as shown in Schedule A to this By-law:

- 9. AND THAT this By-law amends the Traffic and Parking By-law 2018-092
- 10. THAT this by-law shall come into force when it is passed and enacted by Council.
