

## Municipality of Middlesex Centre By-Law 2024-XXX

## Being a By-law of the Corporation of the Municipality of Middlesex Centre to amend the Parking and Traffic By-law 2018-092

**WHEREAS** pursuant to the *Municipal Act, 2001*, S.O. 2001, c.25 the Council of a local municipality may pass by-laws to amend By-Law 2018-092, being a by-law to revise and consolidate certain by-laws regulating Traffic and the Parking of Motor Vehicles.

**NOW THEREFORE BE IT RESOLVED THAT** the Council of the Corporation of the Municipality of Middlesex Centre enacts as follows:

1. That SCHEDULE 16 – HEAVY TRUCK RESTRICTIONS, be amended by the deletion of the following:
