



**Municipality of Middlesex Centre
BY-LAW 2024-051**

**Being a By-law of the Corporation of the Municipality of Middlesex Centre to
amend the Parking and Traffic By-law 2018-092**

WHEREAS pursuant to the *Municipal Act, 2001*, S.O. 2001, c.25 the Council of a local municipality may pass by-laws to amend By-Law 2018-092, being a by-law to revise and consolidate certain by-laws regulating Traffic and the Parking of Motor Vehicles.

NOW THEREFORE BE IT RESOLVED THAT the Council of the Corporation of the Municipality of Middlesex Centre enacts as follows:

1. That SCHEDULE 16 – HEAVY TRUCK RESTRICTIONS, be amended by the deletion of the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>From</u>	<u>Column 3</u> <u>To</u>
Medway Road	Hyde Park Road	Vanneck Road

2. That SCHEDULE 5 – ENTERING HIGHWAY (STOP SIGNS ON SPECIFIED STREETS), be amended by the addition of the following:

<u>Column 1</u> <u>Traffic</u>	<u>Column 2</u> <u>Street</u>	<u>Column 3</u> <u>Intersection</u>
Eastbound	Railway Avenue	Tunks Lane

3. That SCHEDULE 2 – PROHIBITED PARKING ON SPECIFIED STREETS, be amended by the deletion of the following:

<u>Column 1</u> <u>Street</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>From</u>	<u>Column 4</u> <u>To</u>	<u>Column 5</u> <u>Period</u>
Wellington Street	North	Victoria Street	A point 390m East of Victoria St	8 am to 4 pm Sept 1 to Jun 30

4. That SCHEDULE 2 – PROHIBITED PARKING ON SPECIFIED STREETS, be amended by the addition of the following:

<u>Column 1</u> <u>Street</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>From</u>	<u>Column 4</u> <u>To</u>	<u>Column 5</u> <u>Period</u>
Robert Street	East	Ilderton Road	Kennedy Ave	Anytime

5. That SCHEDULE 6 – PEDESTRIAN CROSSOVERS, be amended by the addition of the following:

Column 1 <u>Street</u>	Column 2 <u>Location</u>
York Street	5m south of Young Street
Victoria Street	5m north of Wellington Street

6. AMEND/REPEAL OF BY-LAW:

This By-law amends the Traffic and Parking By-law 2018-092

7. TITLE:

This By-law shall be known as Amendment to the Parking and Traffic By-law – By-law 2024-051

8. FINAL PASSING:

THAT this by-law shall come into force when it is passed and enacted by Council.
