The licensee has applied to the Ministry of Natural Resources and Forestry (MNFR) to amend the site plans for the Stanley Pit to allow for an increase in the below water extraction footprint by relocating a section of the Medway Creek channel within the licence. Geotechnical investigations conducted on the property confirmed that there is a substantial quantity of high-quality aggregates located below the water table within the existing Medway Creek channel and adjacent 30 m setbacks.
