

Municipality of Middlesex Centre By-Law 2024-095

Being a By-Law of the Corporation of the Municipality of Middlesex Centre to establish fees and charges for water and wastewater rates for services provided by the municipality of Middlesex Centre

WHEREAS the Municipality of Middlesex Centre is the owner of water and wastewater systems which services those lands within the areas of the Municipality of Middlesex Centre as listed in Schedule "A" to this By-Law;

AND WHEREAS pursuant to the authority granted by Part XII of The Municipal Act, S.O. 2001, c. 25, as amended the Council of the Municipality of Middlesex Centre may pass By-Laws for the setting of fees and charges for services;

AND WHEREAS pursuant to subsection 391(2) of The Municipal Act, S.O. 2011 provides that a fee or charge imposed for capital costs related to services or activities may be imposed on persons not receiving an immediate benefit from the services or activities but who will receive a benefit at some later point in time;

AND WHEREAS pursuant to By-Law 2010-080 public notice has been provided with respect to the intent to pass water and wastewater rates;

AND WHEREAS the Council deems it appropriate and beneficial to set such water and wastewater rates, and amend those rates from time to time;

NOW THEREFORE BE IT RESOLVED THAT the Council of the Municipality of Middlesex Centre enacts as follows:

- 1. The rates imposed by this By-Law apply to the service areas as defined in Schedule "A" to this By-Law.
- 2. Water service rates are hereby imposed as defined in Schedule "B" to this By-Law.
- 3. Wastewater service rates are hereby imposed as defined in Schedule "C" to this By-Law.
- 4. The rates and charges imposed in Schedule "B" and Schedule "C" to this By-Law shall be billed on a monthly basis.
- 5. The water and wastewater rates and charges imposed by this By-Law are a lien and charge upon the land upon which the said rates and charges are imposed, and if the said rates and charges or any part thereof remain unpaid after the due date, the Treasurer may enter upon the collector's roll the amount due, the person by whom it is due, and the land upon which a lien is claimed and the collector shall proceed to collect it in the same way, as nearly as may be possible, as municipal taxes are collectable.
- 6. By-Law 2023-121 is hereby repealed.
- 7. This By-Law shall come into force and take effect on January 1, 2025.
