Subject:	2024 Year-end By-law Enforcement Update

### **Recommendation:**

**THAT** report BLD-02-2025 regarding the 2024 Year-end By-law Enforcement update be received for information.

## Purpose:

The purpose of this report is to provide council with a year-end update regarding by-law enforcement statistics pertaining to the 2024 calendar year.

### Background:

The Municipality of Middlesex Centre's by-law department operates on a reactive, complaint-basis regarding by-law enforcement, except for violations that are an immediate threat to health or safety of the community. The Municipality is committed to the delivery of municipal law enforcement services in a timely and effective manner. The goal of these services is to achieve compliance with municipal by-laws through education and enforcement.

In December of 2024, following completion of our request for quotations, Middlesex Centre renewed its service contract with Hillside Kennels as the municipality's animal control service provider.

Also in 2024, Middlsex Centre entered into a by-law enforcement service agreement with the Township of Adelaide Metcalfe.

A summary of by-law enforcement activities for 2024 is provided in this report.

## Analysis:

High Level Statistics from January 1, 2024 – December 31st, 2024:

Calls to bylaw enforcement in Middlesex Centre and Lucan Biddulph: 344

- 295 total for Middlesex Centre, up from 256 in 2023
- 49 total for Lucan-Biddulph, up from 43 in 2023

Provincial Offences Notices (PONs) – 17 total


