Competitors travel from Coast to Coast for a three-day competition for the right to be crowned Canadian Champion in either Senior Conventional, Senior Reversible or Junior Conventional.

The winners of both the Senior Conventional and Senior Reversible win the right to represent our great nation at the World Ploughing Championships the following year.

More than two hundred plow persons have competed in the Canadian Plowing Championships with the winners going on to compete at the World Plowing Championships.

In 2026, Middlesex County is proud to host the Canadian Plowing Championships at the farm of Junior and Karen Van Geffen in Strathroy Ontario, August 31-September 4, 2026.
