

## Municipality of Middlesex Centre By-Law 2021-043

Being a by-law to amend the Middlesex center comprehensive zoning by-law number 2005-005 with respect to Concession 2 Part Lot 1 Reg Comp Plan 428 Lot 3 (geographic Township of Delaware), Municipality of Middlesex Centre, roll number: 393901901013800

**WHEREAS** the Council of the Municipality of Middlesex Centre deems it advisable to amend the Middlesex Centre Comprehensive Zoning By-law 2005-005;

AND WHEREAS this By-law is in conformity with the Middlesex Centre Official Plan;

**NOW THEREFORE BE IT RESOLVED THAT** the Council of the Municipality of Middlesex Centre enacts as follows:

- 1) That Zoning Map Schedule 'A', Key Map 84 to the Middlesex Centre Comprehensive Zoning By-law 2005-005 is hereby amended by changing from the 'Agricultural exception 13 (A1-13)' zone to an 'Agricultural exception 13(A1-13)(t-1)' zone that land drawn in heavy solid lines and identified on Schedule 'A', attached hereto and described as being Concession 2 Part Lot 1 Reg Comp Plan 428 Lot 3 (geographic Township of Delaware), Municipality of Middlesex Centre.
- 2) That Section 5.4 "Temporary Uses" be amended by adding the following new subsection:
  - "5.4.25 (a) <u>DEFINED AREA</u>

A1-13(t-1) as shown on Schedule "A", Key Map 84

(b) <u>ADDITIONAL USE PERMITTED</u>

The existing single-detached dwelling is to remain on the subject property for a temporary period, in addition to a new single-detached dwelling and other uses permitted in Section 5.3.13 of this By-law.

(c) <u>EXPIRATION</u>

The provisions of this zoning category will expire on April 28, 2024."

 This by-law comes into force and takes effect upon the day of passing in accordance with the provisions of Section 39 of the <u>Planning Act</u>, R.S.O 1990, c. P.13.
